- 1) ACC approved June 5, 2019 ACC Meeting Minutes Note: July and August ACC Meetings cancelled
- 2) Outstanding May 9 Change Application from homeowners at 1360 Ambergate Ct (Lot#235) for addition of a free standing deck/tree house still on hold awaiting submission of detailed architectural drawings. Jimmy sent them a reminder e-mail message . . . as yet, no response.
- 3) Formally signed "revised" Change Application from homeowner at 17740 Merryhill Court (Lot#7) for replacement of 4 wood retaining walls and replacement of 3 window wells using Pavestone products (possibly 4th window well with pre-manufactured product). Previously given Administrative Approval.
